

## **BROADMAYNE PARISH COUNCIL: REGISTER OF MEMBERS' INTERESTS (as of June 2019)**

The members of Broadmayne Parish Council have given notice to the Monitoring Officer of Dorset Council of the following disclosable pecuniary interests, as required by section 30 of the Localism Act 2011, and as required by the Council's own Code of Conduct.

Spouse or partner means anyone who meets the definition in the Localism Act (i.e. spouse or civil partner, or a person with whom the named councillor is living as if they were civil partners). The councillor must declare any interests of a spouse or partner where he or she is aware that the person has a declarable interest.

In the tables below the interests are defined as follows:

### **Employment, office, trade, profession or vacation**

Any employment, office, trade, profession or vocation carried on for profit or gain.

### **Sponsorship**

Any payment or provision of any other financial benefit (other than from the Council named above) made or provided within the period of 12 months ending with making the declaration in respect of any expenses incurred by a councillor in carrying out duties as a member, or towards his or her election expenses.

This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

### **Contracts**

Any contract which is made between

- The councillor or his/her spouse or partner\*, or
- a firm in which either of them is a partner, or
- a body corporate of which either of them is a director, or
- a body in the securities of which either of them has a beneficial interest)

and the Council named above—

(a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

### **Land**

Any beneficial interest<sup>1</sup> in land which is within the area of the Council named above.

### **Licences**

<sup>1</sup> Beneficial interest could include land or property which a councillor owns, or has a right to occupy (e.g. a tenancy) or receive an income from. This may include his or her home.

Any licence (alone or jointly with others) to occupy land in the area of the Council named above for a month or longer.

**Corporate tenancies**

Any tenancy where (to the councillor's knowledge)—

(a) the landlord is the Council named above; and

(b) the tenant is a body in which the councillor or his/her spouse or partner\* has a beneficial interest.

**Securities<sup>2</sup>**

Any beneficial interest in securities of a body where—

(a) that body (to the councillor's knowledge) has a place of business or land in the area of the Council named above; and

(b) either—

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the councillor or his/her spouse or partner\* has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

<sup>2</sup> “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
