Monitor security of padding to concrete at entrances.

Surfacing

Concrete/grass/timber edgings/rubber tiles.

Surfacing area dimensions

The surfacing fails to meet the requirements of EN1176 in the following respect(s).

The safety surface fails EN1176 as hard materials are within the impact area (potential maximum height falls from the mound of 1.5m). Medium risk

A protective surface is recommended for this item at both tunnel entrances and should be programmed into future development. Medium risk

General Maintenance

Remove exposed hard materials at both tunnel entrances.

It should be noted that well maintained grassed topsoil may provide protection for a maximum fall height of up to 1.0m (see Introductory note 8).

If erosion and puddles remain a problem, the provision of play equipment grass mats laid on mesh/geotextile material on an even surface, chased into the soil at the edges to avoid sharp gradients (<1:5) & trip zones is suggested at both tunnel entrances.

10. Basketball Court

Warning notices should be displayed on the backboard "Do not hang from the ring" as required by BSEN15312.

General Maintenance/safety comments

Loose deteriorated bitmac playing surface likely to have been caused by freezing winter temperatures. Sweep surface, sweeping regularly to clear the loosened stone chippings. Programme to re-surface/bind surface. Medium risk

Loose corrosion to the net chain links, ring & backboard presenting a risk of entering the eyes. *De-scale and coat with lead free paint using appropriate precautions within 6 months.* Medium risk

Some weed growth emerging that may also damage bitmac surfaces. Remove by hand/treating with appropriate non-toxic, non-residual sprays carefully adhering to the application instructions.

Following lack of success in obtaining grants for resurfacing RW/ST to submit grant application to Parish Council. No action to be taken on ring and backboard until decision about resurfacing.

A "service level agreement" for rights of way with Dorset Council

- 1. Councillors will be aware that for many years now it has proved very difficult to get the highway authority (Dorset County Council, now Dorset Council) to cut back overgrown rights of way. This is a particular problem with field-edge paths where the field is being cultivated. Field-edge rights of way should never be cultivated and a width of 1.5m should be left unploughed and unsown in the case of a field-edge footpath and 3m in the case of a field-edge bridleway. Dealing with the natural growth (nettles, brambles, etc.) on such paths is the duty of the highway authority but it appears that they do not have the capacity to deal with this issue on a county-wide basis.
- 2. A parish council does have the power to undertake the maintenance of any footpath, bridleway or restricted byway within its territory (section 43 of the Highways Act 1980) and the highway authority may undertake to defray the whole or part of any cost incurred by the parish council in doing that work. In the light of this, Dorset Council offers what it calls "service level agreements" to parish councils under which it guarantees a minimum of two cuts per year (three if required) of any specified rights of way. The charge for this is 22 pence per meter. This is half of the cost, the other half is met by Dorset Council
- 3. In the table overleaf I suggest the paths, shown in red, which I think could usefully be included in such an agreement if Broadmayne Parish Council wishes to pursue this. Using the Dorset Explorer mapping system, I have made an estimate of the lengths of path involved to obtain a rough costing of such an agreement (the rights of way layer of that system provides the length of each right of way but we don't need the entire length of some of the paths). My estimate comes in at just over £1,300 but I need to check whether a couple of the paths which I've included at the moment do need to be part of this agreement. I would suggest that the agreement should only come into operation in the 2020 growing season since the problem paths are already being harvested now which largely deals with the problem. That being the case, this will only be something to be paid for out of the 2020/21 budget and I will be able to include the necessary funding in the draft budget which I will shortly be preparing.
- 4. The Parish Council needs to decide whether, in principle, it wishes to pursue such an agreement.
